### Guidelines for Phi Beta Delta Award Nominations 2023

**DEADLINE: Sunday, April 30, 2023**

#### Marian Beane / Charles Gliozzo Domestic Student Award for International Achievement

- Superior scholastic achievement is required and therefore the following is required:
  - A nomination letter,
  - A copy of your transcript, and
  - A letter of reference
- A study abroad experience is required and should be described in the letter of nomination and/or letter of support
- All the international activities in which the nominee has participated should be enumerated. These activities may be related to the campus and/or the larger community. The nominee's involvement with Phi Beta Delta should be highlighted.

#### David Merchant International Student Award for Achievement

- Superior scholastic achievement is required and therefore the following is required:
  - A nomination letter,
  - A copy of your transcript, and
  - A letter of reference
- All the international activities in which the nominee has participated should be enumerated. These activities may be related to the campus and/or the larger community. The nominee's involvement with Phi Beta Delta should be highlighted.
- The applicant should be recognized as an international student at the college/university of enrollment (whether in the USA or at an institution overseas).

#### Eileen M. Evans Outstanding Chapter Award

Any active PBD chapter in good standing with the Society is encouraged to submit an application for the outstanding chapter award, demonstrating:

- Significant chapter growth and development;
- Expanded outreach within and beyond the academic community;
- Exemplary programming to promote international education; and
- Outstanding service to Phi Beta Delta Honor Society.

**DEADLINE: Sunday, April 30, 2023**

**Yvonne Captain Faculty Award for Outstanding Contributions to International Education**

- Superior scholastic achievement is required and therefore the following is required:
  - A nomination letter,
  - A curriculum vitae, and
  - Two letters of reference
- The curriculum vitae should include all the teaching, research, creative, administrative, and service activities of an international nature associated with the nominee's career.
- Any honors or other forms of recognition of an international nature should be listed and/or described in either the nomination letter or in the two letters of support.
- Nominators and those writing letters of support are encouraged to provide the Awards Committee with evidence of the significance of the nominee's international activities and/or accomplishments and her/his stature in the field of international education.

**Edward S. Blankenship Outstanding Staff Award**

- Superior scholastic achievement is required and therefore the following is required:
  - A nomination letter,
  - A curriculum vitae / resume, and
  - Two letters of reference
- The nomination materials for this award should clearly delineate the role the nominee has had in the establishment and/or development and/or maintenance of a Phi Beta Delta chapter on a campus.
- Nominators are encouraged to attest to the length of service to and degree of leadership provided to the local chapter by the nominee.
- Two letters of support providing additional evidence of the nominee's activities on behalf of the local chapter and the international community are required.
